2	Papago Trading Post beginning January 1, 1984 through December 31, 1984; and
3	WHEREAS, The Papago Council is authorized by the Constitution to approve leases
4	involving tribal lands; and
5	WHEREAS, The Papago Council has been advised of the terms and conditions of the
	Papago Trading Post lease and approves of the same; and
6	NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
7	approve the lease between the Papago Trading Post and the Papago Tribe
8	for a term beginning January 1, 1984 and ending December 31, 1984, and
9	authorizes the Chairman, Josiah Moore to execute and enter into the
	lease.
10	The foregoing Resolution was duly enacted by the Papago Council on the 7th day of September, 1984, at a meeting at which a quorum was present with a vote of
11	1248.5 for; 191.5 against; -O- not voting; and -O- absent, pursuant to the authority vested in the Papago Council by Section 2 (c) and Section 3
12	(e) and (h) of Article V of the Constitution and By-laws of the Papago Tribe
13	of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to
14	Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the date of its approval by the Superintendent of the Papago
15	Agency and is subject to review by the Secretary of the Interior.
