WHEREAS, The Papago Council has learned of a new Bureau of Indian Affairs policy regarding the eligibility of Indian students to enroll in Bureau of Indian Affairs schools; and

WHEREAS, The Papago Council has been advised that approximately 98 Papago Students may have difficulty enrolling in BIA schools because they do not have the certification to show they are at least 1/4 Indian blood; and

WHEREAS, The Papago Council is desirous of learning the facts and basis for this new policy; and

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby direct the Education Director and the Education Committee to investigate the situation and report back to the Council; and

BE IT FURTHER RESOLVED that the Education Director and the Tribal Attorneys are directed and authorized to research and review all applicable federal acts to determine the basis for this new policy and to determine what course of action to take on behalf of the Papago Tribe; and

BE IT FURTHER RESOLVED that based on the research and review of applicable federal acts that preparations begin to sue Bureau of Indian Affairs for liabilities and if necessary to seek the possible replacement of Bureau staff; and

BE IT FURTHER RESOLVED that a report to the Papago Council be given at the next regular Council meeting.

The foregoing Resolution was duly enacted by the Papago Council on the 24th. day of September, 1984, at a meeting at which a quorum was present with a vote of 1379.0 for; -0- against; 61.0 not voting; and 1 absent, pursuant to the authority vested in the Papago Council by Section 2 (f) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
