3	WHEREAS,	The Papago Council authorizes and approves the expenditure of revenue sharing funds in accordance with identified needs by each of the eleven						
4		districts by requiring the Districts to submit budgets to the Papago						
5	LUISDEAC	Council; and						
6	WHEREAS,	Each of the eleven Districts has, for previous entitlements budgeted certain amounts of revenue sharing funds to cover anticipated costs						
7		for prioritized projects and through no fault of their own, has not						
8		expended such budgeted funds in the fiscal year proposed for such						
9		projects; and						
	WHEREAS,	The Tribal Accounting Department has provided each of the eleven						
10		Districts computer print out sheets detailing budget balances from						
11	MUEDEAS	previous entitlements; and It would be in the best interest of the Districts to amend their cur-						
12	WILLEAS,	rent FY 85 Revenue Sharing budgets to include such balances previously						
13		budgeted for specific projects; and						
14	WHEREAS,	This modification to the FY 85 Revenue Sharing Budgets would not change						
		District proposed plans and previously identified projects can continue						
15	to be undertaken; and							
16	NOW, THE	REFORE, BE IT RESOLVED by the Papago Council that it has reviewed the						
17	-	proposed amendment/modification to the San Xavier District's FY 85						
18		Revenue Sharing Budget incorporating \$21,144.05 from previous Revenue						
19		Sharing entitlements, and hereby approves the expenditure of such funds in accordance with the attached budget.

23	amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of							
24	the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
