1 WHEREAS, The District Council of the Baboquivari District did on September 13,  
2 1984, by Resolution No. 84-005, approve the attached FY 1985 District  
3 Budget in the amount of \$226,765.83; and

4 WHEREAS, The Baboquivari District has sufficient funds in its IIM account to  
5 cover the budget; and

6 WHEREAS, The Papago Council has reviewed the attached budget and approves of  
7 the same; and

8 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby  
9 approve the attached FY 1985 budget of the Baboquivari District and  
10 authorizes expenditures in accordance therewith.

11 The foregoing Resolution was duly enacted by the Papago Council on the 7th  
12 day of November, 1984, at a meeting at which a quorum was present with a vote  
13 of 1440.0 for; -0- against; -0- not voting; and -0- absent, pursuant  
14 to the authority vested in the Papago Council by Section 2 (f) and Section 3  
15 (a) and (h) of Article V of the Constitution and By-laws of the Papago Tribe  
16 of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and  
17 approved by the Secretary of the Interior on January 6, 1937, pursuant to  
18 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is  
19 effective as of the date of its approval by the Superintendent of the Papago  
20 Agency and is subject to review by the Secretary of the Interior.
