7	WHEREAS, In order to assure that such hearings are conducted in an efficient						
8	and timely way and in order to protect the rights of applicants and						
9	the confidentiality of information submitted, the Papago Council has						
10	determined that it is necessary to adopt the attached Rules of Hear-						
11	ing and Procedure for Hearings on Enrollment and Adoption Applica-

13	NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby adopt						
14	the attached Rules of Hearing and Procedure for Hearings on Enrollment						
15	and Adoption Applications which are brought before the Council by the						
16	Enrollment Committee of the Papago Tribe.
