

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
Authorization for Request for Disaster Assistance Funds


1 WHEREAS, The Papago Tribe is aware of the 1983 October Floods in Arizona and
2 damages it caused on the Papago reservation; and
3 WHEREAS, There is Federal monies (FEMA) available for assistance for damages
4 caused by the flood; and
5 WHEREAS, The Papago Council believes it would be in the best interest of the
6 Tribe to request for such funds; and
7 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that Josiah Moore, Chair-
8 man, Francisco Jose, Vice-Chairman, or Rosita Ruiz, Treasurer are
9 hereby authorized and directed to apply for, negotiate and execute
10 any and all contracts, amendments and other documents necessary to
11 obtain such funds.

12 The foregoing Resolution was duly enacted by the Papago Council on the 11th.
13 day of October, 1984, at a meeting at which a quorum was present with a vote
14 of 1440.0 for; -0- against; -0- not voting; and 2 absent, pursuant
15 to the authority vested in the Papago Council by Section 2 (a), (f) and (h)
16 of Article V of the Constitution and By-laws of the Papago Tribe of Arizona
17 as amended, ratified by the Papago Tribe on December 12, 1936, and approved
18 by the Secretary of the Interior on January 6, 1937, pursuant to Section 16
19 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject
20 to review by the Secretary of the Interior and is effective as of the date
21 of its enactment by the Papago Council.
