

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

Appointment of Presiding Judge

(Daniel Lopez)

Res. No. 232-84

1 WHEREAS, Section 2 of Chapter 1 of the Law and Order Code of the Papago Tribe
2 provides that the Papago Tribal Courts shall consist of two regular
3 Judges, and that such Judges "shall be appointed by the Commissioner
4 of Indian Affairs, subject to confirmation by a majority vote of the
5 Papago Council", for a term of two (2) years; and

6 WHEREAS, DANIEL LOPEZ meets all of the qualifications for the position of
7 Presiding Judge of the Papago Tribal Courts; and

8 WHEREAS, The law and Order Committee has recommended that DANIEL LOPEZ be
9 appointed to such position.

10 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
11 designate and confirm the appointment of DANIEL LOPEZ as Presiding
12 Judge of the Papago Tribal Courts for a term of two (2) years from
13 date of appointment, and requests that the Commissioner of Indian
14 Affairs appoint its designee to such position.

15 The foregoing Resolution was duly enacted by the Papago Council on the 7th,
16 day of November, 1984, at a meeting at which a quorum was present with a vote
17 of 1440.0 for; -0- against; -0- not voting; and -0- absent, pursuant
18 to the authority vested in the Papago Council by Section 2 (e) and (f) and
19 Section 3 (b) of Article V of the Constitution and By-laws of the Papago Tribe
20 of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and
21 approved by the Secretary of the Interior on January 6, 1937, pursuant to
22 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is
23 effective as of the date of its approval by the Superintendent of the Papago
24 Agency and is subject to review by the Secretary of the Interior.
