San Lucy District Budget FY-85 IIM Account

1 WHEREAS, The San Lucy District Council has considered and reviewed its  
2 proposed activities for FY-85 and has prepared a proposed budget to  
cover anticipated costs and expenses; and

3 WHEREAS, The San Lucy District Council did by Resolution No. 43-84 adopt a  
4 proposed budget for FY-85 in the amount of \$20,193.00 said budget  
to begin on October 1, 1984 and end on September 30, 1985; and

5 WHEREAS, The Papago Council has reviewed the proposed budget and approves of  
6 same;

7 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it hereby approves the  
8 San Lucy District Council budget to be expended in accordance with  
the attached budgets.

9 The foregoing Resolution was duly enacted by the Papago Council on the 8th  
10 day of November, 1984, at a meeting at which a quorum was present with a vote  
11 of 957.5 for; 138 against; 344.5 not voting; and -0- absent, pursuant to the  
12 authority vested in the Papago Council by Section 2 (f) and Section 3 (a) and  
13 (h) of Article V of the Constitution and By-Laws of the Papago Tribe of Arizona  
as amended, ratified by the Papago Tribe on December 12, 1936, and approved by  
the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the  
Act of June 18, 1934 (48 Stat. 984). Said Resolution is subject to review by the  
Secretary of the Interior
