
1 WHEREAS, The District Council of the Gu Vo District did by Resolution No.
2 26-84 object to the General Tribal Council's recent actions increasing
3 per diem payments and salaries of members of the General Tribal
4 Council, the Enrollment Committee and the Chairman and Vice-Chairman
5 of the Papago Tribe; and

6 WHEREAS, A motion was made to put the matter on the General Tribal Council's
7 December 1984 Council Meeting agenda;


8 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that the concerns raised
9 in the Gu Vo District Resolution No. 26-84 be put on the December
10 1984 General Tribal Council meeting agenda for consideration.

11 The foregoing Resolution was duly enacted by the Papago Council on the 8th day
12 of November, 1984, at a meeting at which a quorum was present with a vote of
13 413.5 for; 566.5 against; 460 not voting; and 1 absent, pursuant to the
14 authority vested in the Papago Council by Section 2 (f) of Article V of the
15 Constitution and By-Laws of the Papago Tribe of Arizona as amended, ratified
16 by the Papago Tribe on December 12, 1936, and approved by the Secretary of the
17 Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934
18 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of
19 the Interior and is effective as of the date of its enactment by the Papago
20 Council.
