

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

Extending a Moratorium on Land Sales, Leases or Development  
Within the San Xavier Reservation Boundaries  
(Third Extension)

Res. No. 239-84

1 WHEREAS, The Papago Council did by Resolution No. 105-83, extended by  
2 Resolution No. 85-84, enact a moratorium on sales, leases or  
3 development of lands within the San Xavier Reservation in order to  
4 put in place a Land Planning & Zoning Ordinance which would provide  
5 for comprehensive, orderly and planned land use and development of  
6 lands within the Papago Reservation; and

7 WHEREAS, The Papago Council has under review a proposed Land & Zoning Ordinance  
8 and needs additional time to consider and review same before  
9 enactment; and

10 WHEREAS, The San Xavier District Council has requested an extension of the  
11 moratorium pending final action by the Papago Council and the  
12 prepared Land Planning & Zoning Ordinance; and

13 NOW THEREFORE BE IT RESOLVED by the Papago Council that it does hereby extend  
14 the moratorium on sales, leases or development of lands within the  
15 San Xavier District for a period of six months.

16 BE IT FURTHER RESOLVED that this moratorium shall not apply to lands lying  
17 within the San Xavier Industrial Park, the Papago-Tucson Foreign  
18 Trade Zone and the San Xavier Farm Cooperative, to lands presently  
19 under lease and to lands designated or approved by the San Xavier  
20 District Council for lease, use or development by the Papago  
21 Housing Authority, The Papago Tribe, the Federal Government or  
22 approved leases (B.I.A. Contract No. 850C-14203636), including  
23 construction of roads, utilities and other public facilities and  
24 project developments contemplated by the Southern Arizona Water  
25 Settlement Act and the Central Arizona Project.

26 The foregoing Resolution was duly enacted by the Papago Council on the 5th  
27 day of December, 1984, at a meeting at which a quorum was present with a vote  
28 of 1239.0 for; -0- against; 201.0 not voting; and -0- absent, pursuant to the  
29 authority vested in the Council by Section 2(c), (f), (h) and (m) and Section 3  
30 (c), (d), (e) and (h) of Article V of the Constitution and By-Laws of the  
31 Papago Tribe as amended, ratified by the Papago Tribe on December 12, 1936,  
and approved by the Secretary of the Interior on January 6, 1937, pursuant to  
Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is  
effective as of the date of its approval by the Superintendent of the Papago  
Agency and is subject to review by the Superintendent of the Interior.
