1	WHEREAS,	The Papago Council did by Resolution No. 105-83, extended by							
2		Resolution No. 85-84, enact a moratorium on sales, leases or							
3		development of lands within the San Xavier Reservation in order to							
4		put in place a Land Planning & Zoning Ordinance which would provide							
5		for comprehensive, orderly and planned land use and development of							
6		lands within the Papago Reservation; and							
7	WHEREAS,	The Papago Council has under review a proposed Land & Zoning Ordinance							
8		and needs additional time to consider and review same before							
9		enactment; and							
0	WHEREAS,	The San Xavier District Council has requested an extension of the							
1		moratorium pending final action by the Papago Council and the							
2		prepared Land Planning & Zoning Ordinance; and							
3	NOW THEREF	ORE BE IT RESOLVED by the Papago Council that it does hereby extend							
4		the moratorium on sales, leases or development of lands within the							
5		San Xavier District for a period of six months.							
6	BE IT FUR	BE IT FURTHER RESOLVED that this moratorium shall not apply to lands lying							
7		within the San Xavier Industrial Park, the Papago-Tucson Foreign							
8		Trade Zone and the San Xavier Farm Cooperative, to lands presently							
9		under lease and to lands designated or approved by the San Xavier							
20		District Council for lease, use or development by the Papago							
21		Housing Authority, The Papago Tribe, the Federal Government or							
22		approved leases (B.I.A. Contract No. 850C-14203636), including							
23		construction of roads, utilities and other public facilities and							
24	NI B	project developments contemplated by the Southern Arizona Water							
25		Settlement Act and the Central Arizona Project.

Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to review by the Superintendent of the Interior.
