San Lucy District Revenue Sharing Budget

1 WHEREAS, The Papago Council has allocated \$28,041.00 of federal revenue
2 sharing funds to the San Lucy District; and


3 WHEREAS, The Papago Council has heard evidence concerning the use of
4 such funds pursuant to the requests presented at the public hearing,
5 including the attached resolution of the District Council of the
6 San Lucy District; and

7 WHEREAS, The Papago Council has reviewed the attached budget and approves of
8 same.


9 NOW THEREFORE BE IT RESOLVED by the Papago Council that the \$28,041.00 of
10 federal revenue sharing funds allocated to the San Lucy District be
11 distributed in accordance with the requests presented at the public
12 hearing and that it does hereby approve the attached 1985 revenue
13 sharing budget of the San Lucy District and authorize expenditures
14 in accordance therewith.

15 The foregoing Resolution was duly enacted by the Papago Council on the 5th
16 day of December, 1984, at a meeting at which a quorum was present with a vote
17 of 1440.0 for; -0- against; -0- not voting; and 2 absent, pursuant to the
18 authority vested in the Papago Council by Section 2 (a) and (d) of Article V
19 of the Constitution and By-Laws of the Papago Tribe of Arizona as amended,
20 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary
of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June
18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the
Secretary of the Interior and is effective as of the date of its enactment by
the Papago Council.
