

1 NOW, THEREFORE BE IT RESOLVED by the Papago Council that it hereby determined
2 that the above named applicants are eligible for enrollment as members
3 of the Papago Tribe under Section 1 (a) or (b) of Article II of the
4 Papago Constitution and By-Laws, as amended, and that their
5 applications are approved, as herein above indicated.

6 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of the
7 Papago Tribe reduce this final determination in writing regarding each
8 of the foregoing applications for enrollment in accordance with
9 Section 3 (c) of Article III of the Papago Tribal Enrollment Ordinance;
10 and place the names of each applicant upon the Tribal membership roll
11 in accordance with Section V of the Papago Tribal Enrollment Ordinance.

12 The foregoing Resolution was duly enacted by the Papago Council on the 5th
13 day of December, 1984, at a meeting at which a quorum was present with a vote
14 of 1440.0 for; -0- against; -0- not voting; and 1 absent, pursuant to the
15 authority vested in the Papago Council by Article III and Section 2 (f) of
16 Article V of the Constitution and By-Laws of the Papago Tribe of Arizona, as
17 amended, ratified by the Papago Tribe on December 12, 1936, and approved by the
18 Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act
19 of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the
20 Secretary of the Interior and is effective as of the date of its enactment by
21 the Papago Council.
