

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
Papago Trading Post Lease

Res. No. 248-84

1 WHEREAS, The Papago Council did by Resolution No. 200-84 approve a lease for
2 the Papago Trading Post for one year; and
3 WHEREAS, The Sells District Business Committee is presently drafting and
4 negotiating a long term lease for the Papago Trading Post and does
5 not expect to have the draft complete by December 31, 1984; and
6 WHEREAS, The Sells District Council believes it would be in the best interest
7 of the community to extend the previous leases through the end of
8 April 30, 1985 so not to interfere with the continuity of business;
9 and
10 WHEREAS, The Sells District Council did by Resolution No. 1284 approve a four
11 month extension, beginning at the end of the current lease term,
12 December 31, 1984 and ending April 30, 1985; and
13 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
14 approve a four month extension of the Papago Trading Post lease
15 beginning January 1, 1985 and ending April 30, 1985 in accordance
16 with the Sells District Council's Resolution No. 1284.

17 The foregoing Resolution was duly enacted by the Papago Council on the 6th
18 day of December, 1984, at a meeting at which a quorum was present with a vote
19 of 1440.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the
20 authority vested in the Papago Council by Section 2 (c) and Section 3 (e) and
21 (h) of Article V of the Constitution and By-Laws of the Papago Tribe of Arizona
22 as amended, ratified by the Papago Tribe on December 12, 1936, and approved by
23 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the
24 Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the
25 date of its approval by the Superintendent of the Papago Agency and is subject
26 to review by the Secretary of the Interior.
