

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(Additions to the Base Roll)

RES. NO. 28-84

1 WHEREAS, the Papago Council has reviewed the recommendations of the Papago
2 Enrollment Committee in accordance with Section 1 of Article VIII
3 of the Papago Enrollment Ordinance, Ordinance No. 05-81, and
4 has made a final determination that the applications of the


26 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above
27 named applicants are eligible for enrollment as members of the
28 Papago Tribe under Section 1 (a) or (b) Article II of the
29 Papago Constitution and By-laws, as amended, and their applica-
30 tions are approved, as herein above indicated.

31 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers
32 of the Papago Tribe reduce this final determination in writing
regarding each of the foregoing applications for enrollment in
accordance with Section 1 (c) or Article VIII of the Papago
Enrollment Ordinance; give notice of this Council's determina-
tion in accordance with Section 2 (a) or (b) of Article VIII
of the Papago Enrollment Ordinance; and place the names of
each applicant upon the Tribal Membership Roll in accordance
with Article IX of the Papago Enrollment Ordinance.

The foregoing Resolution was duly enacted by the Papago Council on the 28
day of February 1984, at a meeting at which a quorum was present with a
vote of 1386,5 for; 0 against; 53.5 not voting; and 1 absent
pursuant to the authority vested in the Papago Council by Article II and
Article V. Section 2 (f) of the Constitution and By-laws of the Papago Tribe
of Arizona as amended, ratified by the Papago Tribe on December 12, 1936,
and approved by the Secretary of the Interior on January 6, 1937, pursuant
to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution
is not subject to review by the Secretary of the Interior and is effective
as of the date of its enactment by the Papago Council.


