

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(Appointment of Vice Chairman Francisco Jose to Follow-Up on Issues)
(of Special Appropriations Committee's Priorities)

RES. NO. 33-84

1 WHEREAS, the Papago Council did by Resolution No. 09-82 appoint a Committee
2 of two persons to prepare and present to the United States Congress
3 testimonies on the proposed federal budgets as it may affect the
Papago Tribe; and

4 WHEREAS, the Papago Council has since the passage of Resolution No. 09-82
5 appointed Council members to carry out the objectives of the
Resolution; and

6 WHEREAS, the Papago Council did not appoint an Appropriations Committee for
7 Fiscal Year 1984 but did authorize the presentation of issues/concerns
8 to the United States Congress and other key federal agencies; and

9 WHEREAS, four members of the Papago Council volunteered their time to prepare
10 testimonies and information on selected vital issues/concerns for
11 presentation to the Fiscal Year 1984 budget oversight hearings and
to other key federal agencies; and

12 WHEREAS, this Committee traveled to Washington, D.C., and presented the issues
of vital concern to the Papago Tribe; and

13 WHEREAS, the Fiscal Year 1984 Appropriations issues and concerns presented
14 to the United States Congress are of vital concern to the welfare
of the Papago people and will require follow through; and

15 WHEREAS, the Papago Council is desirous of specifically designating a person
16 to follow through on the issues through their conclusion or
17 resolution.

18 NOW THEREFORE BE IT RESOLVED by the Papago Council that Francisco Jose, Vice
19 Chairman of the Papago Council is hereby designated to follow
20 through on the issues presented to the United States Congress and
other federal agencies during the Fiscal Year 1984 budget oversight
hearings; and

21 BE IT FURTHER RESOLVED by the Papago Council that Francisco Jose report to
22 the Papago Council at each Council meeting henceforth on their
23 status until resolution or conclusion is met on each of the issues.

24 The foregoing Resolution was duly enacted by the Papago Council on the 8th
day of March, 1984, at a meeting at which a quorum was present with a vote
25 of 1440.0 for; -0- against; -0- not voting; and 3 absent, pursuant
26 to the authority vested in the Papago Council by Section 2 (f) and (m) of
Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
27 amended, ratified by the Papago Tribe on December 12, 1936, and approved by
the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
28 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to
review by the Secretary of the Interior and is effective as of the date of
its enactment by the Papago Council.
