NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it hereby approves 10 the addition of \$65,499.65 to Baboquivari's FY '84 budget to be 11 expended in accordance with the attached budgets with the exception 12 of the R.V. Parking Lot and for the projects identified by the 13 District Council. The foregoing Resolution was duly enacted by the Papago Council on the 5th day of April, 1984, at a meeting at which a quorum was present with a vote of 1440.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the authority vested in the Papago Council by Section 3 (a) of Article 15 V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, 16 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the 17 Act of June 18, 1934 (48 Stat. 984).
