WHEREAS, the Constitution Committee of the Papago Council has presented a final draft of a proposed Constitution for the Papago Tribe to the Papago Council for review and approval; and

WHEREAS, the Papago Council has reviewed the proposed final draft, section by section, and finds that it is desirable to make certain necessary changes at this point;

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it hereby accepts the recommendation of the Constitution Committee to amend Article VI, "Powers of the Council", Section 1 from:

> "The Papago Council shall, in accordance with established customs of the Papago Nation and subject to the express limitations contained in this Constitution, have the following powers:"

to:

"The Papago Council shall have all of the legislative powers which are vested in the Papago Nation and shall, in accordance with established customs of the Papago Nation and subject to the express limitations contained in this Constitution, have the powers:"

The foregoing Resolution was duly enacted by the Papago Council on the 26th day of April, 1984, at a meeting at which a quorum was present with a vote of 1333.0 for; 53.5 against; 53.5 not voting; and 1 absent, pursuant to the authority vested in the Papago Council by Section 2 (f) and (h) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
