RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

Amend Article VI, Section 1, Subsection (c)

RES. NO. 60-84

WHEREAS, the Constitution Committee of the Papago Council has presented a 1 final draft of a proposed Constitution for the Papago Tribe to the 2 Papago Council for review and approval; and 3 WHEREAS, the Papago Council has reviewed the proposed final draft, section by section, and finds that it is desirable to make certain necessary 4 changes at this point; 5 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it hereby amends 6 Article VI, "Powers of the Council", Section 1, Subsection (c) of 7 the proposed Constitution from: (c) "To exercise the inherent powers of the Papago 8 Nation by providing ordinances: 9 to: 10 "To exercise the inherent powers of the Papago (c) Nation by enacting laws, ordinances or resolutions". 11 The foregoing Resolution was duly enacted by the Papago Council on the 26th 12 day of April, 1984, at a meeting at which a quorum was present with a vote of <u>1440.0</u> for; <u>-0-</u> against; <u>-0-</u> not voting; and <u>1</u> absent, pursuant to the authority vested in the Papago Council by Section 2 (f) and (h) of Article V 13 of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the 14 Act of June 18, 1934 (48 Stat. 984).
