

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

Base Roll Additions

RES. NO. 68-84

1 WHEREAS, Section I (a) of Article II of the Constitution of the Papago Tribe
2 as amended, provides that the Papago Council can make additions and
3 changes to the official census rolls of the Sells and Gila Bend
4 Reservations dated January 1, 1937, and of the San Xavier Reservation
5 dated January 1, 1940, subject to the approval of the Secretary of the
Interior; and

6 WHEREAS, the Enrollment Committee has determined that the following named
7 persons were members of the Papago Tribe on the date of the respective
8 census rolls but that their names had been inadvertently omitted
9 therefrom, and has recommended that their names be added to the rolls;
and

10 WHEREAS, the Papago Council has reviewed the recommendations of the Enrollment
Committee and approves thereof.


11 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that, subject to the
12 approval of the Secretary of the Interior, the names of the following
13 persons be added to the official census rolls of the Sells, Gila Bend
or San Xavier Reservation, to wit:

14 796-GV-75 WEYRAUCH, Maria Cruz
(Ortiz)
15 1047-SO-75 PABLO, Josie

16 BE IT FURTHER RESOLVED that the required approval be secured from the
17 Secretary of the Interior before their names be formally added to
such rolls.


18 The foregoing Resolution was duly enacted by the Papago Council on the 27th
19 day of April, 19 84, at a meeting at which a quorum was present with a
20 vote of 1318.0 for; -0- against; -0- not voting; and 6 absent,
21 pursuant to the authority vested in the Papago Council by Article II and
22 Article V, Section 2 (f) of the Constitution and By-laws of the Papago Tribe
of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and
approved by the Secretary of the Interior on January 6, 1937, pursuant to
23 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not
24 subject to review by the Secretary of the Interior and is effective as of the
25 date of its enactment by the Papago Council.
