## RESOLUTION OF THE PAPAGO TRIBAL COUNCIL Resignation of Secretary to Tribal Council

RES. NO. 70-84

WHEREAS, the position of Secretary to the Papago Tribal Council became vacant 1 upon the resignation of Francisco Osife and it is necessary to appoint 2 another Secretary; and 3 WHEREAS, Francisco Osife, Secretary to the Papago Tribal Council has submitted a letter of resignation to be effective upon the arrival of the 4 newly hired Secretary or June 29, 1984, or whichever comes first; and 5 WHEREAS, the Papago Council has reviewed the resignation and accepts the same. 6 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it hereby accepts 7 the resignation of Francisco Osife and directs that a job announcement for the position of Secretary of the Papago Council be made, posted 8 and distributed in accordance with the Personnel and Procedure Manuel. 9 The foregoing Resolution was duly enacted by the Papago Council on the 27th day of April, 1984, at a meeting at which a quorum was present with a vote of 10 1318.5 for; 69.0 against; 52.5 not voting; and 4 absent, pursuant to the authority vested in the Council by Section 2 (f) of Article V of the Constitution and By-laws of the Papago Tribe as amended, ratified by the 11 Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934, 12 (48 Stat. 984).
