NO. 72-84 WHEREAS, The Constitution Committee of the Papago Council has presented a 1 final draft of a proposed Constitution for the Papago Tribe to the 2 Papago Council for review and approval; and WHEREAS, the Papago Council has reviewed the proposed final draft section by 3 section and finds that it is desirable to make certain necessary 4 changes at this point. 5 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it hereby changes 6 Article X "Elections", Section 1 of the proposed Papago Constitution by removing Section T from the proposed Constitution and inserting 7 it as a new paragraph in the Election Ordinance. 8 The foregoing Resolution was duly enacted by the Papago Council on the 8th day of May, 1984, at a meeting at which a quorum was present with a vote of 1180.0 for; -0- against; 153.0 not voting; and 4 absent, pursuant to the authority vested in the Papago Council by Section 2 (f) and (h) of Article 9 10 V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the 11 Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review 12 by the Secretary of the Interior and is effective as of the date of its 13 enactment by the Papago Council.
