

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

San Lucy Land Purchase be finalized at June, 1984
Council Meeting

Res. No. 79-84

1 WHEREAS, the Papago Council did by Resolution No. 03-84 authorize the appropri-
2 ate officer, attorneys and agents of the Papago Tribe to negotiate
3 the acquisition of 297 acres of land from Eleanor A. Logan, a real
estate broker acting for an undisclosed principal;


4 WHEREAS, Resolution No. 03-84 further requested the assistance of the Bureau
5 of Indian Affairs in the negotiation of the land purchase; and

6 WHEREAS, The San Lucy District Council representatives have informed the Papago
7 Council that no action has taken place and no reports or information
8 have been provided the San Lucy District on the status of the negotia-
tion; and


9 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it hereby directs the
10 officers, attorneys and agents of the Papago Tribe authorized in
11 Resolution No. 03-84 to negotiate the acquisition of 297 acres of
12 land from Eleanor A. Logan, a real estate broker, to report the status
of the acquisition to the Papago Council explaining reasons for any
inaction, if such is the case.

13 The foregoing Resolution was duly enacted by the Papago Council on the 9th
14 day of May, 1984, at a meeting at which a quorum was present with a
15 vote of 1440,0 for; -0- against; -0- not voting; and 1 absent,
pursuant to the authority vested in the Papago Council by Section 2 (a)
16 of Article V of the Constitution and By-laws of the Papago Tribe of
17 Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and
approved by the Secretary of the Interior on January 6, 1937, pursuant to
18 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is
not subject to review by the Secretary of the Interior and is effective as
of the date of its enactment by the Papago Council.
