San Lucy District Budget Amendment FY-1983 - 1984

1 WHEREAS, the Papago Tribal Council did on September 16, 1983 approve the San Lucy District budget for fiscal year 1984 in the amount of 2 \$49,390.52; and, 3 WHEREAS, the San Lucy District Council did on May 7, 1984 approve to amend 4 their FY-84 District budget to increase this budget by \$5,000.00 for the following: 5 Loan to the Vi'ikam Doag Industries, Inc. \$3,750.00 6 \$1,250.00 Total \$5,000.00 7 and, 8 WHEREAS, the San Lucy District Council does have sufficient funds in

9 their IIM account to cover the additional amount requested. NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby 10 approve the modification of the San Lucy District budget for 11 FY-84 and authorizes the addition of \$5,000.00 to the original 12 amount of \$49,390.52 bringing the total budget to \$54,390.52. and also it does hereby authorize the transfer of \$5,000 from the 13 San Lucy District IIM account to the San Lucy District checking 14 account with the Valley National Bank at Gila Bend, account number 15 2186-1432.

16 The foregoing Resolution was duly enacted by the Papago Council on the <u>11th</u> day of <u>May</u>, <u>1984</u>, at a meeting at which a quorum was present with a vote of <u>1237.0</u> for; <u>203.0</u> against; <u>-0-</u> not voting; and <u>1</u> absent, pursuant to the authority vested in the Papago Council by Section <u>3 (a) and</u> (h) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to review by the Secretary of the Interior.
