15	October 01, 1984 and end September 30, 1985.							
	BE IT FURTHER RESOLVED that the Papago Tribe will not fund or operate							
16	programs from which contracts are requested herewith which have							
17	not been negotiated and executed by the Bureau of Indian Affairs							
18	prior to the start of the funding year.							
	BE IT FURTHER RESOLVED that Joaish Moore, Chairman, Francisco Jose, Jr.,							
19	Vice Chairman or Rosita Ruiz, Treasurer, of the Papago Council							
20	is hereby authorized to negotiate and execute these contracts							
21	and any amendments thereto for the duration of the contracts.

22	day of May, 1984, at a meeting at which a quorum was present with a vote of 1333.0 for; -0- against 107.0 not voting; and 3 absent, pursuant to the

24	Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved
