49 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of  
50 the Papago Tribe reduce this final determination in writing regarding  
51 each of the foregoing applications for enrollment in accordance with  
52 Section 3 (c) of Article III of the Papago Tribal Enrollment  
53 Ordinance; give notice of this Council's determination in accordance  
54 with Section 4 of Article III of the Papago Tribal Enrollment  
55 Ordinance; and place the names of each applicant upon the Tribal  
56 membership roll in accordance with Aritcle V of the Papago Tribal  
57 Enrollment Ordinance.

1 The foregoing Resolution was duly enacted by the Papago Council on the 08th  
2 day of January, 1986, at a meeting at which a quorum was present with a vote  
3 of 1523.0 for; -0- against; 117.0 not voting; and -0- absent, pursuant to the  
4 authority vested in the Papago Council by Article II and Article V, Section 2  
5 (f) of the Constitution and By-laws of the Papago Tribe of Arizona as amended,  
6 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary  
7 of the Interior on January 6, 1937, pursuant to Section 16 of the Act of  
8 June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the  
9 Secretary of the Interior and is effective as of the date of its enactment by  
10 the Papago Council.
