NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby determine that the applicant of:

SELINA C. SALAZAR

for adoption as a member of the Papago Tribe is hereby rejected.

BE IT FURTHER RESOLVED that the Chairman of the Papago Council shall issue a certificate of Final Determination of Rejection and that the Enrollment Committee serve Notice of Rejection of the application in accordance with the provisions of Section 1 and 2, Article VIII of the Papago Enrollment Ordinance.
