

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Rejection of application for adoption)
(of ROSEMARY MANUEL (OSIFE))

RES. NO. 106-86

1 WHEREAS, An application for adoption as a member of the Papago Tribe of the
2 Papago Reservation has been filed by or on behalf of:

3 ROSEMARY MANUEL (OSIFE) 1326-H-83
4 ("Applicant") (Namely Application No.)

5 filed on the 06TH day of JUNE, 19 83; and

6 WHEREAS, The Enrollment Committee has reviewed the application and has recom-
7 mended that the application be denied because the applicant is not
8 one-half degree or more of Papago Indian blood; and

9 WHEREAS, The application has come on for hearing before this Council; and

10 WHEREAS, The Enrollment Committee did serve written notice of its recommen-
11 dation to reject the application and of this hearing, as required by
12 Section 2, Article VII of the Papago Enrollment Ordinance, upon the
13 person who filed the application and such person was/was not present
14 at this hearing; and

15 WHEREAS, The Papago Council has reviewed all of the evidence presented and
16 from such evidence finds that the applicant does not have one-half
17 degree or more of Papago Indian blood as required by Section 1(b) of
18 Article II of the Papago Constitution.

19 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
20 determine that the applicant of: ROSEMARY MANUEL (OSIFE)

21 for adoption as a member of the Papago Tribe is hereby rejected.


22 BE IT FURTHER RESOLVED that the Chairman of the Papago Council shall issue a
23 certificate of Final Determination of Rejection and that the En-
24 rollment Committee serve Notice of Rejection of the application in
25 accordance with the provisions of Section 1 and 2, Article VIII of
26 the Papago Enrollment Ordinance.

27 The foregoing Resolution was duly enacted by the Papago Council on the 27th
28 day of February, 1986, at a meeting at which a quorum was present with a vote
29 of 1279.5 for; -0- against; 360.5 not voting; and 01 absent, pursuant to

the Secretary of the Interior and is effective as of the date of its enactment
by the Papago Council.
