6 WHEREAS, The Enrollment Committee has reviewed the application and has recom-
7 mended that the application be denied because the applicant failed
8 to establish the following membership requirement(s): TOHONO
9 O'ODHAM CONSTITUTION & BY-LAWS ARTICLE II MEMBERSHIP - SECTION (1A) &

12 WHEREAS, The application has come on for hearing before this Council; and

13 WHEREAS, The Enrollment Committee did serve written notice of its recommen-
14 dation to reject the application and of this hearing, as required by
15 Section 2, Article VI of the Tohono O'odham Enrollment Ordinance, upon
16 the person who filed the application and such person was/was not
17 present at this hearing; and

19 WHEREAS, The Tohono O'odham Council has reviewed all of the evidence presented
20 and from such evidence finds that the applicant has failed to es-
21 tablish the foregoing membership requirement(s).

22 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does here-

24 RAUL A. PARRA JR.


25 for enrollment as a member of the Tohono O'odham Nation is hereby

Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
