

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL


(Rejection of membership application of)
(Jennifer L. Jones)

1 WHEREAS, An application for enrollment as a member of the Papago Tribe of the
2 the Papago Reservation has been filed by or on behalf of:

4 Jennifer L. Jones No District
 ("Applicant") (Namely Application No.)
5 filed on the 2nd day of October, 1974; and
6 WHEREAS, The Enrollment Committee has reviewed the application and has recom-
7 mended that the application be denied because the applicant failed
8 to establish the membership requirements of Section 1 of Article II
9 of the Constitution of the Papago Tribe, as amended; and
10 WHEREAS, The application has come on for hearing before this Council; and
11 WHEREAS, The Enrollment Committee did publish written notice of its recommen-
12 dation to reject the application and of this hearing, as required by
13 Section 2, Article IV of the Papago Enrollment Ordinance, amended
14 by Resolution No. 349-85, and neither the applicant or applicant's
15 sponsor appeared at this hearing; and

17 WHEREAS, The Papago Council has reviewed all of the evidence presented and
18 from such evidence finds that the applicant has failed to establish
19 the foregoing membership requirement(s).

21 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
22 determine that the application of:

24 **Jennifer L. Jones**
25 for enrollment as a member of the Papago Tribe is hereby rejected.
26 BE IT FURTHER RESOLVED that the Chairman of the Papago Council shall issue a
27 Certificate of Final Determination of Rejection and that the Enroll-
28 ment Committee publish Notice of Rejection of the application in
29 accordance with the provisions of Section 1 and 2, Article VIII of
30 of the Papago Enrollment Ordinance, as amended by Resolution No.
31 349-85 of the Papago Council.

1 The foregoing Resolution was duly enacted by the Papago Council on the 28th
2 day of February, 1986, at a meeting at which a quorum was present with a vote
3 of 1492.5 for; 147.5 against; -0- not voting; and 01 absent; pursuant
4 to the authority vested in the Papago Council by Article II and Section 2 (f)
5 of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
6 amended, ratified by the Papago Tribe on December 12, 1936, and approved by the
7 Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act
8 of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by
9 the Secretary of the Interior and is effective as of the date of its enactment
10 by the Papago Council.
