

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(In Opposition to Termination of Tribal Health Management)

RES. NO. 179-86

1 WHEREAS, The Balanced Budget and Emergency Deficit Control Act of 1985 (P.L.
2 99-177) mandates that budget deficits be reduced within the next five
3 (5) fiscal years beginning with FY 1986; and

4 WHEREAS, The President has submitted the FY 87 Federal budget to Congress and
5 proposed within that budget and reduction or termination of funding
6 for several federal programs including Tribal Health Management under
7 Indian Health Service; and

8 WHEREAS, The Papago Council opposes any reduction of funding for the Tribal
9 Health Management program because it provides support for the
10 administrative, fiscal and operational management, and delivery of
11 health services to eligible recipients;

13 WHEREAS, The President has espoused a policy of self-determination reaffirming
14 the intent of P.L. 93-638 and any reduction or termination of Tribal
15 Health Management support funds would effectively frustrate the
16 Tribe's effort and development of self- determination goals and
17 objectives in the health care delivery program; and

18 WHEREAS, The Tribal Health Management funds provide the core to the Papago
19 Tribe's health program and would be severely and adversely impacted by
20 this proposed action.


22 NOW, THEREFORE BE IT RESOLVED by the Papago Council that it does hereby
23 strongly oppose any reduction or termination of funding for the Tribal
24 Health Management program under Indian Health Service, and
25 respectfully urges Congress to carefully review the merits of the
26 President's proposal, and to restore and continue funding for the
27 Tribal Health Management program to continue the policy of self-
28 determination as reaffirmed by the President and Congress.

30 The foregoing Resolution was duly enacted by the Papago Council on the 28th
31 day of February, 1986, at a meeting at which a quorum was present with a vote
32 of 1640.0 for; -0- against; -0- not voting; and 02 absent, pursuant to the
authority vested in the Papago Council by Section 2 (d), (f) and (h) of Article


