NOW, THEREFORE, BE IT RESOLVED by the Papago Council that the \$15,146.00 of federal revenue sharing funds allocated to the Schuk Toak District be distributed in accordance with the requests presented at the public hearing and that it does hereby approve the attached 1986 revenue sharing budget of the Schuk Toak District and authorize expenditures in accordance therewith.

The foregoing Resolution was duly enacted by the Papago Council on the 12th day of March, 1986, at a meeting at which a quorum was present with a vote of 1640.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the authority vested in the Papago Council by Section 2 (a) and (d) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
