
27 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above

31 approved, as herein above indicated.

32 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of
the Papago Tribe reduce this final determination in writing regarding
each of the foregoing applications for enrollment in accordance with
Section 3 (c) of Article III of the Papago Tribal Enrollment
Ordinance; give notice of this Council's determination in accordance
with Section 4 of Article III of the Papago Tribal Enrollment
Ordinance; and place the names of each applicant upon the Tribal


1 membership roll in accordance with Article V of the Papago Tribal
2 Enrollment Ordinance.

3 The foregoing Resolution was duly enacted by the Papago Council on the 13th
4 day of March, 1986, at a meeting at which a quorum was present with a vote of
5 1402.0 for; -0- against; 238.0 not voting; and -0- absent, pursuant to the
6 authority vested in the Papago Council by Article II and Article V, Section 2
7 (f) of the Constitution and By-laws of the Papago Tribe of Arizona as amended,
8 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
