(Recognition of Relinquishment of Membership in the Papago Tribe)




6 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
7 recognize that ENAS, (ANTONE) Frances R.; DAVIS (ENAS), Noreen K.;
8 MATTIA, Elvia; MILES (LEWIS), Sharon; THOMAS, Janelle S.; CONGER,
9 Jason Scott; have renounced membership in the Papago Tribe, and does
10 hereby order that their name(s) be deleted from the membership roll.

11 The foregoing Resolution was duly enacted by the Papago Council on the 13th
12 day of March, 1986, at a meeting at which a quorum was present with a vote of
13 1518.5 for; -0- against; 121.5 not voting; and -0- absent, pursuant to the
14 authority vested in the Papago Council by Article II and Article V, Section 2
15 (f) of the Constitution and By-laws of the Papago Tribe of Arizona as amended,
16 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary
of the Interior on January 6, 1937, pursuant to Section 16 of the Act of
June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the
Secretary of the Interior and is effective as of the date of its enactment by
the Papago Council.
