Said Resolution was presented for approval to the Chairman of the Tohono O'Odham Nation on the $\underline{O^{(4)}}$ day of Section 5 of Article VII of the Constitution and will become effective upon his approval; provided, however, that if it was passed by the Council pursuant to the powers vested in the Council by Section 2 of Article VI of the Constitution it shall become effective only upon the
