( Rejection of membership application of )  
( JOHN L. GONZALES )

1 WHEREAS, An application for enrollment as a member of the Tohono O'odham Nation  
2 has been filed by or on behalf of:

3 JOHN L. GONZALES 2791-S-85  
4 ("Applicant") (Namely Application No.)

5 filed on the 7th day of OCTOBER, 1985; and

6 WHEREAS, The Enrollment Committee has reviewed the application and has recom-  
7 mended that the application be denied because the applicant failed  
8 to establish the following membership requirement(s): TOHONO O'ODHAM  
9 CONSTITUTION, ARTICLE II, MEMBERSHIP - SECTION (1A) & (1B); and

10 WHEREAS, The application has come on for hearing before this Council; and

11 WHEREAS, The Enrollment Committee did serve written notice of its recommen-  
12 dation to reject the application and of this hearing, as required by  
13 Section 2, Article VI of the Enrollment Ordinance, upon the person who  
14 filed the application and such person was/was not present at this  
15 hearing; and

16 WHEREAS, The Tohono O'odham Council has reviewed all of the evidence presented  
17 and from such evidence finds that the applicant has failed to es-  
18 tablish the foregoing membership requirement(s).

20 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does here-  
21 by determine that the application of:

22 JOHN L. GONZALES  
23 for enrollment as a member of the Tohono O'odham Nation is hereby  
24 rejected.

26 BE IT FURTHER RESOLVED that the Chairman of the Tohono O'odham Nation shall  
27 issue a certificate of Final Determination of Rejection and that the  
28 Enrollment Committee serve Notice of Rejection of the application in  
29 accordance with the provisions of Section 1 and 2, Article VIII of  
30 of the Enrollment Ordinance.

1 The foregoing resolution was passed by the Tohono O'odham Council on the 24th  
2 day of March, 1986, at a meeting at which a quorum was present with a  
3 vote of 1270.0 for; -0- against; 232.0 not voting; and 138.0 absent,  
4 pursuant to the powers vested in the Council by Article II and Section 1 (h) of  
5 Article VI of the Constitution of the Tohono O'odham Nation, adopted by the  
6 Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy  
7 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to  
8 Section 16 of the Act of June 18, 1934 (48 Stat. 984).
