

RESOLUTION OF THE TOHONO O'ODHAM COUNCIL

(Appointing Government Coordinating Committee)

RES. NO. 219-86

1 WHEREAS, the Constitution adopted by the qualified voters of the Tohono  
2 O'Odham Nation on January 18, 1986, was approved by the Acting Deputy  
3 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,  
4 and became effective on that date; and

5 WHEREAS, the Constitution establishes three independent branches of govern-  
6 ment, namely, the Legislative, consisting of the Tohono O'Odham  
7 Council; the Executive, consisting of the Office of the Chairman of  
8 the Tohono O'Odham Nation; and the Judicial, consisting of the Tohono  
9 O'Odham Judiciary; and

11 WHEREAS, it is anticipated that many problems will arise from the reorgani-  
12 zation and restructuring of the government be coordinated in such a  
13 way as to cause a minimum of friction, dislocation and cost, and that  
14 the transition be as harmonious as possible; and

15 WHEREAS, the Budget & Finance Committee has recommended the establishment of  
16 a Government Coordinating Committee, consisting of representatives  
17 from all three branches of government to coordinate the activities  
18 of their respective branches of government and develop an adminis-  
19 trative plan in order to facilitate the reorganization and restruc-  
20 turing of the government into three separate branches.

22 NOW, THEREFORE BE IT RESOLVED by the Tohono O'odham Council that it does  
23 hereby appoint the following persons, or representatives from their  
24 respective branches of government, to a Government Coordinating Comm-  
25 ittee which shall coordinate the activities of their respective  
26 branches of government and develop an administrative plan in order to  
27 facilitate the reorganization and restructuring of the government of  
28 the Tohono O'odham Nation into three separate branches, namely:

12 BE IT FURTHER RESOLVED that the Committee designate a person, either from  
13 within or without the Committee, to coordinate and manage the  
14 activities of the Committee; that all officers and employees of the  
15 Tohono O'Odham Nation cooperate with the Committee, or individual  
16 teams and members in the work of the Committee and that the Committee  
17 report periodically to the Council concerning the activities, the  
18 administrative plan, and any problems which may arise and may require  
19 legislative action.

20 The foregoing Resolution was passed by the Tohono O'Odham Council on the 24th  
21 day of March, 1986, at a meeting at which a quorum was present with a vote of  
22 1336.0 for; 304.0 against; -0- not voting; and -02- absent, pursuant to the  
23 powers vested in the Council by Section 1 (a) and (b) of Article VI of the Con-  
24 stitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on  
25 January 18, 1986, and approved by Deputy Assistant Secretary - Indian Affairs  
26 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
27 1934 (48 Stat. 984). Said Resolution was presented for approval to the Chair-  
28 man of the Tohono O'Odham Nation on the \_\_\_\_\_ day of \_\_\_\_\_, 1986, at \_\_\_\_\_  
29 o'clock, \_\_\_\_\_M. pursuant to the provisions of Section 5 of Article VII of the  
30 Constitution and will become effective upon his approval; provided, however,  
31 that if it was passed by the Council pursuant to the powers vested in the Coun-  
32 cil by Section 2 of Article VI of the Constitution it shall become effective  
only upon the further approval of the Secretary of the Interior.
