2 votes in favor of Harriet Toro as Chairperson of the Tohono O'Odham
3 Council; and

4 WHEREAS, This Council hereby wishes to commemorate and certify its election
5 of Harriet Toro as Chairperson of the Tohono O'Odham Council.


6 NOW, THEREFORE, BE IT RESOLVED by the Council that it does hereby commemorate
7 and certify the election of Harriet Toro as Chairperson of the
8 Tohono O'Odham Council.

10 The foregoing resolution was passed by the Tohono O'odham Council on the 7th
11 day of April, 1986, at a meeting at which a quorum was present with a vote of
12 1577.0 for; 63.0 against; -0- not voting; and 01 absent, pursuant to the powers
13 vested in the Council by Section 1 (b) of Article VI of the Constitution of the
14 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
1934 (48 Stat. 984).


