2 votes in favor of Andrew Patricio for Vice-Chairman of the Tohono
3 O'Odham Council; and

4 WHEREAS, This Council hereby wishes to commemorate and certify its election of
5 Andrew Patricio as Vice Chairman of the Council.

6 NOW, THEREFORE, BE IT RESOLVED by the Council that it does hereby commemorate
7 and certify the election of Andrew Patricio as Vice-Chairman of the
8 Tohono O'Odham Council.

10 The foregoing resolution was passed by the Tohono O'odham Council on the 7th
11 day of April, 1986, at a meeting at which a quorum was present with a vote of
12 1456.5 for; 183.5 against; -0- not voting; and 01 absent, pursuant to the
13 powers vested in the Council by Section 1 (b) of Article VI of the Constitution
14 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January
15 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian
16 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
17 June 18, 1934 (48 Stat. 984).
