

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving delegation of authority to Chairman and  
Vice Chairman of Legislative Council)

RES. NO. 223-86

1 WHEREAS, The Executive Committee of the Tohono O'Odham Legislative Council did  
2 recommend that the Council adopt the attached Official Delegation of  
3 Authority to the Chairman and Vice - Chairman of the Council; and

5 WHEREAS, The Council has reviewed the recommendations of the Executive  
6 Committee and approves thereof, subject, however to later additions or  
7 amendments thereto.

8 NOW, THEREFORE, BE IT RESOLVED by the Council that it does hereby approve and  
9 adopt the attached official Delegation of Authority to the Chairman  
10 and Vice Chairman of the Council, subject to later additions or  
11 amendments thereto by the Council, and does hereby delegate to them  
12 full authority to:  
13

- 14 1. Presides at all Council meetings.
- 15 2. Perform duties of the Chairman.
- 16 3. Follow up on the implementation of legislation.
- 17 4. Ex-Officio (non-voting) member of all legislative committees.
- 18 5. With consent of the Tohono O'Odham Council, act as representa-  
19 tive of the Council.
- 20 6. Approve and/or sign off on all expenditures of the legislature.
- 21 7. Assist Legislative Secretary in ensuring that all proper items  
22 meet the established requirements of legislature.
- 23 8. Official liaison to Executive and Judicial branches.
- 24 9. Coordinate activities and schedules with Vice-Chairman and  
25 Secretary.
- 26 10. Officially notify Vice-Chairman of his absence.
- 27 11. Report on all matters involving, affecting, and benefitting the  
28 Nation.

29 The foregoing resolution was passed by the Tohono O'odham Council on the 7th  
30 day of April, 1986, at a meeting at which a quorum was present with a vote of  
31 1449.5 for; -0- against; 190.5 not voting; and 01 absent, pursuant to the  
32 powers vested in the Council by Section 1 (b) of Article VI of the Constitution  
of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January  
18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian  
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of  
June 18, 1934 (48 Stat. 984).
