

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Delegation of Authority to Secretary of the Council)

RES. NO. 224-86

1 WHEREAS, The Executive Committee of the Tohono O'Odham Legislative Council did
2 recommend that the Council adopt the attached official Delegation of
3 Authority to the Legislative Secretary; and


4 WHEREAS, The Council has reviewed the recommendations of the Executive
5 Committee and approves thereof, subject, however, to later additions
6 or amendments thereto.

7 NOW, THEREFORE, BE IT RESOLVED by the Council that it does hereby approve and
8 adopt the attached official Delegation of Authority, as amended, to
9 the Legislative Secretary of this Council, subject to later additions
10 or amendments thereto by the Council, and does hereby delegate to her
11 full authority to:

- 13 1. Keep legislature informed on all matters affecting legislation
14 and the Nation.
- 15 2. Shall keep all official documents of the Nation.
- 16 3. Provide the Legislature with an official recording of pro-
17 ceedings for each meeting for review and approval.
- 18 4. Administer and manage the office of Legislative Secretary's
19 Office.
- 20 5. Implement official policies of the Legislature regarding the
official use and access to National documents.

21 The foregoing resolution was passed by the Tohono O'odham Council on the 7th
22 day of April, 1986, at a meeting at which a quorum was present with a vote of
23 1640.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the powers
24 vested in the Council by Section 1 (b) of Article VI of the Constitution of the
25 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secre- tary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
1934 (48 Stat. 984).
