Vice Chairman of the Council must, in contemplation of Section 4 of

Article V of the Constitution, coincide with the biennial general

elections of the Nation.

NOW, THEREFORE, BE IT RESOLVED that the Chairman and Vice-Chairman of this Council shall hold their respective offices until the next general election of the Nation and until after the newly elected representatives have been seated, at which time the legislative Secretary of the Council shall assume the position of protem Chairperson of the Council to preside at the election of their successors in office.

The foregoing resolution was passed by the Tohono O'odham Council on the 7th day of April, 1986, at a meeting at which a quorum was present with a vote of 1471.0 for; 169.0 against; -O- not voting; and O1 absent, pursuant to the powers vested in the Council by Section 1 (b) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
