

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Setting terms of office for Chairman and Vice-Chairman
of Council)

RES. NO. 225-86

1 WHEREAS, The Council did by Resolutions No. 220-86 and No. 221-86 respectively
2 elect Harriet Toro and Andrew Patricio as Chairperson and Vice-
3 Chairman of this Council without specifying any definite terms of
4 office; and
5

6 WHEREAS, The Council believes that the terms of office of the Chairman and
7 Vice Chairman of the Council must, in contemplation of Section 4 of
8 Article V of the Constitution, coincide with the biennial general
9 elections of the Nation.

10 NOW, THEREFORE, BE IT RESOLVED that the Chairman and Vice-Chairman of this
11 Council shall hold their respective offices until the next general
12 election of the Nation and until after the newly elected represen-
13 tatives have been seated, at which time the legislative Secretary of
14 the Council shall assume the position of protem Chairperson of the
15 Council to preside at the election of their successors in office.

17 The foregoing resolution was passed by the Tohono O'odham Council on the 7th
18 day of April, 1986, at a meeting at which a quorum was present with a vote of
19 1471.0 for; 169.0 against; -0- not voting; and 01 absent, pursuant to the
20 powers vested in the Council by Section 1 (b) of Article VI of the Constitution
21 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January
22 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
23 1934 (48 Stat. 984).
