

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Affecting Terms of Office of Elected Public Officers)

RES. NO. 228-86

1 WHEREAS, Section 3 of Article X of the Constitution of the Tohono O'Odham
2 Nation provides that "no person holding an elective public office of
3 the Tohono O'Odham Nation shall hold any other elective office of the
4 Tohono O'Odham Nation;" and

5 WHEREAS, a number of representatives and their alternates to the Tohono O'Odham
6 Legislative Council also hold office as representatives or alternates
7 to a District Council and the Executive Committee of the Tohono
8 O'Odham Legislative Council has advised the Council that it will be
9 necessary that they vacate one of these offices in order to comply
10 with the foregoing constitutional provision.

11 NOW, THEREFORE, BE IT RESOLVED by the Council that all primary representatives
12 and their alternates on this Council who also hold office as represen-
13 tatives or alternates on a District Council shall submit their re-
14 signation from one of these Councils.

15 BE IT FURTHER RESOLVED that the resignations be submitted and acted upon by
16 May 7, 1986, which is the next regularly scheduled session of the
17 Council.

18 The foregoing resolution was passed by the Tohono O'odham Council on the 8th
19 day of April, 1986, at a meeting at which a quorum was present with a vote of
20 1241.0 for; 399.0 against; -0- not voting; and 02 absent, pursuant to the
21 powers vested in the Council by Section 1 (e) of Article VI of the Constitution
22 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January
23 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian
24 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
June 18, 1934 (48 Stat. 984).
