

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Sif Oidak District Budget Amendment FY 86)

RES. NO. 234-86

1 WHEREAS, The Sif Oidak District Council did by Resolution No. 02-86 approve an  
2 amendment of the District's FY 86 Budget which would increase the  
3 Budget from \$192,347.92 to \$319,726.31; and has requested this Council  
4 to (1) approve the amendment, (2) to approve its request to open and  
5 maintain a separate District checking and/or Savings Account with the  
6 First Interstate Bank of Arizona, Casa Grande, Arizona, with authority  
7 in any of the following District Council Officers to sign checks  
8 issued upon such Accounts, namely; the Chairman, Vice-Chairman, or  
9 Secretary-Treasurer, and to approve the transfer of funds on deposit  
10 in the District's I.I.M. Account into the aforementioned Accounts with  
11 the First Interstate Bank, and;

13 WHEREAS, This Council has reviewed the District's request and has determined  
14 that the District has sufficient funds available to cover the proposed  
15 expenditures.

17 NOW, THEREFORE, BE IT RESOLVED that this Council; (1) Approves the requested  
18 amendment of the Sif Oidak District's FY 86 from \$192,347.92 to  
19 \$319,726.31 as requested by Resolution No. 02-86; (2) Authorizes the  
20 District Council to open and maintain a separate Checking and/or  
21 Savings Account with First Interstate Bank with authority in any of  
22 the designated District Council Officers to sign the checks issued  
23 upon such Accounts; (3) Approves the transfer of the appropriate funds  
24 from the District's I.I.M. Accounts into the aforementioned Bank  
25 Accounts.

27 The foregoing resolution was passed by the Tohono O'odham Council on the 9th  
28 day of April, 1986, at a meeting at which a quorum was present with a vote of  
29 1640.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the powers  
30 vested in the Council by Section 1 (d) of Article VI of the Constitution of the  
31 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
32 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
1934 (48 Stat. 984).
