WHEREAS, The Sif Oidak District Council did by Resolution No. 02-86 approve an amendment of the District's FY 86 Budget which would increase the Budget from \$192,347.92 to \$319,726.31; and has requested this Council to (1) approve the amendment, (2) to approve its request to open and maintain a seperate District checking and/or Savings Account with the First Interstate Bank of Arizona, Casa Grande, Arizona, with authority in any of the following District Council Officers to sign checks issued upon such Accounts, namely; the Chairman, Vice-Chairman, or Secretary-Treasurer, and to approve the transfer of funds on deposit in the District's I.I.M. Account into the aforementioned Accounts with the First Interstate Bank, and;

WHEREAS, This Council has reviewed the District's request and has determined that the District has sufficient funds available to cover the proposed expenditures.

NOW, THEREFORE, BE IT RESOLVED that this Council; (1) Approves the requested amendment of the Sif Oidak District's FY 86 from \$192,347.92 to \$319,726.31 as requested by Resolution No. 02-86; (2) Authorizes the District Council to open and maintain a seperate Checking and/or Savings Account with First Interstate Bank with authority in any of the designated District Council Officers to sign the checks issued upon such Accounts; (3) Approves the transfer of the appropriate funds from the District's I.I.M. Accounts into the aformentioned Bank Accounts.

The foregoing resolution was passed by the Tohono O'odham Council on the 9th day of April, 1986, at a meeting at which a quorum was present with a vote of 1640.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the powers vested in the Council by Section 1 (d) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
