

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Wise Ones Elderly Program Title III)

RES. NO. 235-86

1 WHEREAS, the Tohono O'Odham Nation has operated successfully a program for
2 elderly members and residents of the Tohono O'Odham Nation called the Wise
3 Ones Elderly Program; and

4 WHEREAS, funding for the Wise Ones Elderly Program has been provided in part
5 by Title III of the Older Americans Act of 1965, as amended through the
6 administration by the InterTribal Council of Arizona; and

7 WHEREAS, the Wise Ones Elderly Program will require continued financial
8 assistance to continue providing minimum services to eligible clients; and

9 WHEREAS, the Wise Ones Elderly Program has prepared a proposal for FY-87
10 for Title III funding to provide transportation, homecare, and other support
11 to eligible elderly clients; and

12 WHEREAS, the continued operation of the elderly program will be beneficial
13 to elderly clients;

14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that it hereby
15 approves the proposal for Title III funding for the Wise Ones Elderly Program
16 to continue to provide such services as it has proposed in light of the
17 requirements and regulations;

18 BE IT FURTHER RESOLVED that the duration of this contract will be from July
19 01, 1986 through June 30, 1987 unless extended by mutual agreement of both
20 contracting parties;

21 BE IT FURTHER RESOLVED by the Tohono O'Odham Council that the Tohono O'Odham
22 Nation will not fund or operate the program in the interim while negotiations
23 are still being conducted and no executed contract has been awarded by the
24 InterTribal Council of Arizona;

25 BE IT FURTHER RESOLVED that Josiah Moore, Chairman; Francisco Jose, Vice-Chairman;
26 or Rosita Ruiz, Treasurer are hereby authorized and directed to negotiate and
27 execute any and all contracts, amendments, and other necessary documents to
28 secure funding for the continued operation of the Wise Ones Elderly Program.

1 The foregoing resolution was passed by the Tohono O'Odham Council on the 9th
2 day of April, 1986, at a meeting at which a quorum was present with a vote of
3 1581.5 for; -0- against; 58.5 not voting; and -0- absent, pursuant to the
4 powers vested in the Council by Section 1 (f) of Article VI of the Constitution
5 of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on
6 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
7 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
8 Act of June 18, 1934 (48 Stat. 984).
