1	WHEREAS, section 4 of Article VIII of the Constitution of the Tohono O'Odham
2	Nation provides that "[w]ithin sixty (60) days after the effective date of
3	this constitution, the Tohono O'Odham Council shall appoint at least six (6)
4	judges of the Tohono O'Odham Courts"; and
5	WHEREAS, the Law & Order Committee of the Council has recommended a tentative
6	Time Schedule for Judges' Selection with which the Council concurs.
7	NOW, THEREFORE, BE IT RESOLVED by the Council that it does hereby adopt the
8	Law & Order Committee's tentative Time Schedule For Judges Selection as the
9	schedule for the appointment of the six (6) judges of the Tohono O'Odham
10	Courts.
11	The foregoing resolution was passed by the Tohono O'Odham Council on the 9th day of April, 1986, at a meeting at which a quorum was present with a vote of
12	1393.5 for; 246.5 against; -0- not voting; and -0- absent, pursuant to the powers vested in the Council by Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
