

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Authorizing existing Committees to carry out their Functions  
until October 01, 1986)


1 WHEREAS, the Executive Committee of the Tohono O'Odham Legislative Council has  
2 recommended that the Council permit all existing committees and boards  
3 previously established by the Papago Council to continue to function until  
4 October 01, 1986, pending final action by the Council formally re-structuring  
5 the boards and committees, either as legislative or executive committees and  
6 boards re-defining their functions and jurisdiction under the new Constitution  
7 of the Tohono O'Odham Nation; and

8 WHEREAS, the Council concurs with the recommendation of the Executive Committee.


9 NOW, THEREFORE, BE IT RESOLVED by the Council that all existing committees and  
10 boards previously established by the Council are hereby authorized to continue  
11 to function until October 01, 1986, pending final action by the Council  
12 formally re-structuring the boards and committees and re-defining their  
13 functions and jurisdiction under the new Constitution of the Tohono O'Odham  
14 Nation.

15 The foregoing resolution was passed by the Tohono O'Odham Council on the 9th  
16 day of April, 1986, at a meeting at which a quorum was present with a vote of  
17 1523.5 for; 63.5 against, 52.5 not voting; and -0- absent, pursuant to the  
18 powers vested in the Council by Section 1 (b) and (d) of Article VI of the  
19 Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation  
20 on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
21 Indian Affairs (Operations) on March 06, 1986, pursuant to Section 16 of the  
22 Act of June 18, 1934 (48 Stat. 984).
