

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Conditional Approval of Adoption of Terisita L. Sakiestewa)


1 WHEREAS, The application for adoption into membership of the Tohono O'odham
2 Nation filed by or on behalf of Terisita L. Sakiestewa, Application
3 No. 1343-B-74, came before this Council upon the recommendation of
4 the Enrollment Committee, and
5

6 WHEREAS, The Council has determined that the applicant, Terisita L.
7 Sakiestewa, is the adopted child of Madeline Sakiestewa who was
8 present at the hearing and informed the Council that the applicant
9 was adopted; that at the time of adoption she was informed that the
10 applicant was the natural child of a Tohono O'odham; that the appli-
11 cant has applied for further information from the adoption court
12 concerning her biological parents, pursuant to the Indian Child
13 Welfare Act, but to date has been unable to obtain such further in-
14 formation.

16 NOW, THEREFORE, BE IT RESOLVED by the Council that it does hereby conditionally
17 approve the application of Terisita L. Sakiestewa for adoption into
18 the Tohono O'odham Nation, conditioned upon presentation of additional
19 evidence from the records of the adoption court that her natural
20 parent was Tohono O'odham with sufficient blood quantum to qualify
21 the applicant for membership in the Nation.

23 The foregoing resolution was passed by the Tohono O'odham Council on the 10th
24 day of April, 1986, at a meeting at which a quorum was present with a vote of
25 749..5 for; 699.0 against; 191.5 not voting; and -0- absent, pursuant to the
26 powers vested in the Council by Section 1 (h) of Article VI of the Constitution
27 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January
18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
June 18, 1934 (48 Stat. 984).
